The Acts of Kindness committee granted eight requests in May; seven were directly tied to housing. The other was to help with a cell phone bill, so the recipient could communicate about jobs so that he could afford his own apartment.

Because of the Salt Lake City Rotary Club, twenty-five people – men, women and children – can continue to live in their homes. The problems they experienced that put their homes at risk were emergency costs that they were unable to meet and pay their rent. The committee is acutely aware of the precarious situations people face every day.

Rotarians, pat yourself on the back. Because of you these families are secure, and another can communicate with possible employers. Thank you for your generosity.
